NELSON BALIDO CHAIRMAN BORDER COMMER

Nelson Balido drives results in diverse government, politics, private industry, and non-profit arenas. As one of the leading authorities on the U.S. border for trade, travel, and security issues, he leads Balido and Associates, a strategic management consultancy, and founded the Border Commerce and Security Council in 2013.

Before assuming his current role, he was the President of the Border Trade Alliance and a presidential pick to lead the private sector division of the Federal Emergency Management Agency. He also served on the Homeland Security Advisory Council, where he was awarded the department's highest civilian award – the Outstanding Public Service Medal.

In 2021, he was appointed as a consultant to the DHS Undersecretary of Intelligence, and in 2023, he was appointed as a special advisor in the office of the Commissioner for Customs and Border Protection.

Nelson has worked closely with the U.S., Canada, and Mexico governments at every level for years by advocating for policy initiatives designed to improve cross-border affairs, trade and security relations, energy reform, and cultural understanding. Nelson is also a United States Navy Reserve officer with Special Operations Command North – U.S. Northern Command.

Dr. Steven Camarota is the Director of Research at the Center for Immigration Studies (CIS), focusing on the impacts of immigration in the U.S.

He promotes informed debates on immigration reform by providing data to policymakers and the public. Since 1999, he has testified before Congress 30 times regarding immigration's economic and demographic effects. His research has appeared in major publications and has been cited by the National Academy of Sciences and the U.S. Supreme Court.

Dr. Camarota holds a master's in political science from the University of Pennsylvania and a doctorate in public policy analysis from the University of Virginia.

C. LeRoy Cavazos-Reyna is a nationally recognized strategist and public affairs leader with expertise in government relations, crossborder diplomacy, and inclusive economic development. He is the Founder and CEO of Localism, Inc., a certified Hispanic-, LGBTQ+-, and Disability-owned consulting firm based in San Antonio, Texas, focused on empowering minority-owned businesses and nonprofits through policy, procurement, and stakeholder engagement.

He also serves as Senior Advisor to Public Private Strategies, where he leads national and global initiatives to support small businesses and equitable economic growth.

Previously, LeRoy was Vice President of Government and International Affairs for the United States Hispanic Chamber of Commerce (USHCC), where he helped revitalize the organization during the COVID-19 pandemic and led its first-ever international office opening in Mexico City. He has also held senior roles at Coca-Cola Southwest Beverages/Arca Continental, the San Antonio Hispanic Chamber of Commerce (SAHCC) and MHP Salud, where he led more than ten international trade missions to LATAM, Europe, and the Middle East. An alumnus of the Texas Lyceum and a strong advocate for U.S. Mexico collaboration, LeRoy served on the Texas Border Coalition, San Antonio Mexico Friendship Council, and numerous civic boards. He holds a Master of Public Administration and dual bachelor's degrees from the University of Texas Rio Grande Valley, and an advanced leadership certification from TCU's Neeley School of Business.

He resides in San Antonio, Texas, with his husband Edgar and remains an active voice in civic, policy, and business communities across the globe.

He began his career at the El Paso Herald-Post and later at The Wall Street Journal and the El Paso Herald-Post.

Corchado, a native of Mexico, is the author of Homelands: Four Friends, Two Countries, and the Fate of the Great Mexican-American Migration (Bloomsbury Publishing, 2018) and Midnight in Mexico (Penguin Books, 2013).

Corchado has been a visiting fellow at the David Rockefeller Center at Harvard University, a visiting scholar at the Woodrow Wilson Center, a recipient of the Lannan Residency Fellowship, a USMEX fellow at the University of California at San Diego, and a Neiman Fellow at Harvard University. He was also an IOP fellow at the University of Chicago. He also won the Maria Moors Cabot and Elijah Parish Lovejoy Awards for Courage in Journalism. In 2023, he was inducted into the National Association of Hispanic Journalists Hall of Fame for his three-plus decades covering the border and Mexico.

Roberto Coronado is the senior vice president and senior economist at the Federal Reserve Bank of Dallas, overseeing community engagement and development.

He fosters partnerships with community and business leaders to shape economic understanding in Texas, southern New Mexico, and northern Louisiana, aiding community development initiatives.

His research focuses on the Mexican economy and U.S.-Mexico economic integration, and he serves as the El Paso Branch regional executive. Coronado is also a board member for several organizations and holds a doctorate in economics from the University of Houston, along with degrees from the University of Texas at El Paso.

Honorable Mayor John Cowen, Jr. is a dedicated public servant from a family with deep roots in Brownsville.

Elected as City Commissioner At-Large in 2019 and then as Mayor in 2023, he has led initiatives enhancing the city's competitiveness. He is also President of Cowen Group, Ltd., specializing in customs brokerage and real estate.

Mayor Cowen is a sought-after speaker on economic development and serves on multiple boards, including the U.S. Conference of Mayors and the Rio Grande Valley Metropolitan Planning Organization.

A licensed U.S. Customs Broker, he holds a Business Administration degree from the University of Notre Dame and works to position Brownsville as a business hub.

Charles C. Foster is the Chairman of Foster LLP in Houston and has been the Honorary Consul General of Thailand since 1997. A recognized immigration law expert, he represents multinational firms and foreign investors and has received accolades such as Best Lawyer in America and Top 100 attorney in Houston. Charles has a J.D. and undergraduate degree from the University of Texas at Austin and frequently lectures on immigration law.

He has served as a senior immigration policy advisor for Presidents George W. Bush and Barack Obama and has testified before U.S. Senate and House subcommittees. Charles is involved in multiple organizations, including founding Chairman of the Immigration & Nationality Law Section of the Texas State Bar, and has held leadership roles in various committees and boards.

Notable community contributions include co-chairing several monument advisory boards and serving on various boards related to immigration reform and cultural understanding. He has received numerous awards for his service, including the Asia Society's Roy M. Huffington Award and the National Immigration Forum's Keeper of the American Dream Award. Charles is Board Certified in Immigration and Nationality Law and is fluent in Spanish.



PRESIDENT VICENTE FOX

FORMER PRESIDENT OF MEXICO

Vicente Fox Quesada was Mexico's 62nd president (2000-2006), the first opposition candidate to win after 72 years of one-party rule. His presidency achieved significant advancements, including a 43% decrease in poverty, a reduction of public debt from \$84.6 to \$54.7 billion, over \$67 billion in reserves, a 354% rise in the stock market, and social reforms benefiting 75.5 million people.

Fox joined the National Action Party (PAN) in the 1980s, served in Congress in 1988, and became governor of Guanajuato in 1995. Before politics, he had a successful career at Coca-Cola, becoming its youngest manager. He holds degrees from Universidad Iberoamericana and Harvard. As Director of the Fox Group, he focuses on agriculture and manufacturing.

He founded the Fox Center to support youth leadership and low-income children and has spoken at over 300 conferences worldwide, advocating for freedom, equality, transparency, leadership, and peace.



TECLO J. GARCIA

CHIEF EXECUTIVE OFFICER

Mr. Garcia is an economic development and public affairs professional with more than 20 years of leadership and experience in municipal government communications with demonstrated success in advocacy, community affairs, public policy, and marketing.

Before taking the helm in Mission, Teclo led the City of Laredo's Department of Economic Development, where he worked with the private sector to create hundreds of new jobs and billions in new development during his tenure at North America's busiest land port. Additionally, Mr. Garcia was the Director of Government Affairs for the City of McAllen and the Editor in Chief of the Brownsville Herald. Teclo is a United States Air Force veteran - serving as a noncommissioned officer overseas during Desert Storm - and is a graduate of Texas State University-San Marcos.



THE HONORALBE ANTONIO GARZA FORMER U.S AMBASSADOR TO MEXICO, SENIOR ADVISOR WHITE & CASE LLP

Antonio Garza is a Senior Advisor at White & Case LLP in Mexico City and Chairman of Vianovo Ventures. He was the U.S. Ambassador to Mexico from 2002 to 2009. With decades of legal, political, and business experience, Garza advises CEOs, investors, and entrepreneurs on U.S.-Mexico relations and market strategy.

Garza serves on the boards of Canadian Pacific Kansas City, the Greenbrier Companies, the Texas Tribune, Americas Society/Council of the Americas, and the American Chamber of Commerce in Mexico City. He is a recipient of Mexico's highest honor for a foreign national, the Águila Azteca. Garza is a trustee of Southern Methodist University, director of the George W. Bush Foundation, chair of the Bush Center's Advisory Council, member of the Council on Foreign Relations and COMEXI, and former Chairman and President of the Texas Exes alumni association of UT.

Additionally, Garza served as Chairman of the Texas Railroad Commission, Vice Chairman of the Interstate Oil and Gas Compact Commission, Texas Secretary of State, Senior Policy Advisor to the Governor, and Cameron County Judge.
