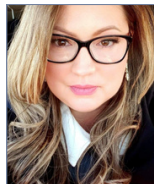
Welcome to Laredo, Texas!

He holds a Ph.D. in Business Competitiveness and Economic Development, along with multiple degrees in Political Science, Business Administration, and related fields.

Dr. Jeremy Everett is the founder and executive director of the Baylor University Collaborative on Hunger and Poverty, which integrates research, policy, and practice through various projects aimed at combating hunger. With nearly 80 staff and 28,000 partner organizations, the Collaborative has facilitated the distribution of millions of meals through innovative interventions. Dr. Everett has raised over \$300 million for research and public service during his tenure.

Before his current role, he worked as a teacher, religious leader, community organizer, and farmer, and frequently speaks on hunger and poverty. He holds degrees from Samford University, Baylor University, and Duke University and has served on various boards, including the National Commission on Hunger. He is an author of several books on hunger and social justice, including the upcoming *The Litmus Test*.

Dr. Everett is married to Reverend Amy Miley Everett, and they have three sons.

Henry J. Flowers Portillo is a Ph.D. student in Agricultural and Applied Economics at Texas Tech University. His research lies at the intersection of international trade, causal policy evaluation, and forecasting, with a focus on U.S. meat exports and policy shocks affecting global agricultural markets.

His dissertation combines econometric and machine-learning methods to examine export recovery following food-safety crises and the economic impacts of public security reforms. Henry has presented his work at national conferences and has teaching experience in agribusiness marketing, statistics, and applied economics.

In 2010, he changed roles and began working fresh produce sales and special projects roles which would span several South Texas grower-shipper-importers prior to assuming the position of President & CEO for the Texas International Produce Association in 2017.

Today, the association represents nearly 450 member companies throughout the fresh produce supply chain, as TIPA educates, advocates, promotes and represents the more than \$13 billion in fresh produce that is either grown in the state of Texas or considers Texas its first point of domestic arrival for North American distribution.

Hilda Gutiérrez is the Vice President of Partnerships and Strategic Initiatives at Feeding Texas, where she leads neighbor engagement strategies and cross-sector partnerships to strengthen regional food systems and address root causes of hunger. She previously directed food access initiatives at Sustainable Food Center, expanding programs that helped thousands of Central Texans access fresh, local food and scaling Double Up Food Bucks statewide. A native of the Rio Grande Valley and daughter of Mexican immigrants, Hilda's early experiences as a farmworker shape her commitment to building equity in the food system. She holds degrees from Southwestern University and the University of New Mexico.

Skip Hulett is the Chief Legal Officer at NatureSweet®, a leading controlled environment agriculture company in Texas, known for its Cherub® and Glory® snacking tomatoes. NatureSweet focuses on vertical integration and positively impacting communities, employing nearly 10,000 workers in Mexico and the U.S. Skip has a distinguished career as chief legal counsel for entrepreneurial firms, a state district court judge, and a law firm founder. After law school, he gained respect quickly and served as a judge appointed by the Texas Governor.

He later became General Counsel for a telecommunications company that grew from \$15 million to over \$1 billion in revenue. Since joining NatureSweet in 2018, he has led initiatives such as achieving B-Corp Certification, making it the largest CEA company to do so. He is active in various industry organizations and holds degrees from Lamar University and Texas Tech University School of Law, while being a member of the State Bar of Texas and the Association of Corporate Counsel.

He was a member of TFB's 2020 Vision Committee and participated in the Food Dialogues panels to help foster communication between consumers and farmers. Dan Hunter was appointed as the state executive director of the USDA Farm Service Agency in Texas by the Trump Administration in July 2025. Previously, he was the assistant commissioner for the Texas Department of Agriculture (TDA), advising on economy, trade, and water issues, and overseeing rural affairs programs. His career includes roles as executive director of the Texas Institute for Applied Environmental Research, adjunct professor at Tarleton State University, and government relations representative for the National Cotton Council.

Hunter has served on various advisory committees and holds degrees from Texas Tech University, Tarleton State University, and Western Texas College. He was recognized as Outstanding Alumnus by Texas Tech. Raised on a family farm in Roscoe, Texas, he now resides in College Station with his wife Ana, has two children and four grandchildren, and enjoys hunting, golfing, and family time.

Her mission is to increase access to fresh, local, and healthy food that is produced sustainably. Marcella holds a master's degree in Agricultural Education with a specialization in hydroponics and sustainable agriculture and has over 13 years of agricultural production experience. Born and raised in Laredo, Marcella works at the intersection of food, health, economic opportunity, and environmental stewardship.

Stephen Lucke, Founder of Gardopia Gardens, is food systems expert, activist, and professor focusing on health and environmental justice who educates and empowers communities on how to lead healthy and sustainable lifestyles through urban agriculture.

He became aware of San Antonio's obesity epidemic and climate crises in his college years, sparking his journey to help find a solution to declining planetary and population wellness that disproportionately impacts BIPOC communities. In 2015, Stephen founded Gardopia Gardens to help solve the challenges facing his community by working with educational and community institutions to ensure current and future generations have the knowledge and skills to cultivate a high quality of life for themselves and society, fighting against malnutrition related diseases and environmental degradation.



GERRY SCHWEBEL

EXECUTIVE VICE PRESIDENT

Gerardo (Gerry) Schwebel is the Executive Vice President of the Corporate International Division at IBC Bank, part of International Bancshares Corporation. He is a leading expert on North American trade and finance, frequently testifying before Congress on U.S.-Mexico trade issues, including NAFTA and USMCA. Since 1996, he has led the International Division and has held key positions in various organizations, including former chair of the Border Trade Alliance and the North America Strategy for Competitiveness. Schwebel is involved with the U.S. Chamber of Commerce and the U.S.-Mexico Economic Council, focusing on trade policy and facilitation.

He has received numerous awards for his contributions to economic development and transportation, including the Russell H. Perry Award in 2019. Previously, he was CEO of PAZ Energy and worked at ARCO Oil & Gas, where he negotiated with U.S. and Mexican governments and helped deregulate the natural gas market. He has held several Presidential appointments, including White House Fellow and Assistant Secretary of the Interior.

Gen. Zapanta led a UN peacekeeping mission and was appointed by the Secretary of Defense as Chairman of the Reserve Forces Policy Board. His military honors include the Silver Star and multiple Bronze Stars for Valor. He serves on various boards and foundations, including Tyson Foods and the Gerald R. Ford Foundation. Mr. Zapanta holds a BA in Industrial Psychology, an MA in Public Administration, and has pursued a PhD in International Political Economics from USC, along with completing graduate studies at Harvard and the Inter-American Defense College.
