## Annual Independent Poll Reveals Texans' Diverse Attitudes

## The Lyceum Poll Finds:

- Texans see immigration and border security as the most important issue facing the state (combined total of $31 \%$ pushes education to third place this year), while the economy and jobs are seen as the most important issue facing the country (combined total of 20\%)
- On immigration, a majority of adult Texans believe unaccompanied children from Central America who illegally crossed the border this past summer should be sent home as soon as possible - but a majority of Hispanics and Democrats feel they have a right to stay.
- On abortion, Texans overwhelmingly believe abortion should be legal in the case of rape, incest and to protect the life of a mother ( $68 \%$ for each respectively). With regard to birth defects, abortion support decreases, but a majority still favors legal abortions in this circumstance.
- The Affordable Care Act remains unpopular with Texans despite more than 7 million Americans having signed up for private health insurance under the law.
- Texans view themselves as healthy ( $86 \%$ ) and oppose a tax ( $68 \%$ ) on full calorie, sugary soft drinks to encourage better health and curb the obesity epidemic.
(AUSTIN) An independent statewide poll conducted by the Texas Lyceum, a non-partisan, nonprofit statewide leadership group, suggests that Texans are split evenly when it comes to addressing the immigration crisis at the border the number one issue in the state, surpassing education; Texans are accepting of a woman obtaining an abortion under a number of circumstances, and Texans still feel negatively about the Affordable Care Act.


## Immigration/Refugee Crisis

The Texas Lyceum's $8^{\text {th }}$ annual poll, which was conducted September 11 - 25, shows most adult Texans (48 percent) supportive of sending unaccompanied
children from Central America who illegally crossed the border this past summer home rather than allowing them to stay to await an immigration hearing. It is important to note support to send refugees home deepens to 56 percent among likely voters. However, opinion varies considerably when looking at ethnicity and race. Sixty-two percent of Anglos believe they should be deported compared to 28 percent who said they should be allowed to stay. Among Hispanics polled, the numbers nearly reverse. Fifty-eight percent of Hispanics support allowing the children to remain in the United States to await immigration hearings, while 33 percent said they should be returned. African Americans were more evenly divided, but a plurality supports the children staying in the United States, 48-41 percent.
"Although the majority response sides with law and order, we do see that the attitudes of Texans depend on context," said Lyceum pollster University of Texas Professor Daron Shaw. "If immigration is framed in terms of caring for children, our willingness to compromise increases."

## Abortion/Various Circumstances

Abortion has emerged as an important issue in the 2014 Texas gubernatorial election with just five weeks to go. When surveyed, a large majority of adult Texans (68 percent) believe abortion should be legal in cases of rape, incest or to protect the life of the mother. When asked, "there will be a strong chance of a serious defect in the baby," a smaller majority ( 54 percent) believe a woman should be able to have an abortion. In the remaining three circumstances queried - the family has a low income, the woman is unmarried, or the third, she doesn't want any more children - fewer Texans, 33 percent support a woman's right to obtain an abortion.

## Affordable Care Act/Healthcare

While the Affordable Care Act, known as Obamacare, has been in effect for more than a year and 7.2 million Americans have purchased private health insurance under the law, 48 percent of adult Texans still have an unfavorable view of the law, while 33 percent hold a favorable opinion. Among likely voters the ACA gets even lower marks (52 percent unfavorable - 35 percent favorable).

Texans see themselves and their families as healthy, but view most other Texans and Americans as marginally healthy. However, it appears that Texans do not support raising funds for public health initiatives by levying a tax on full-calorie, non-diet, soda drinks, fully 68 percent of adults oppose the idea of a sin tax among likely voters the percent in opposition increases to 73.

## Most Important issues facing state/nation

For the past four years in the Texas Lyceum poll, Texans have said that the most important issue facing the nation is the economy. That remains true with a combined total of 20 percent of adults choosing the economy and jobs. However, on the state level, Texans believe that immigration (19 percent) and border
security ( 13 percent), for a combined total of 31 percent, are the most important issue facing the state, which could be expected considering the media attention this past summer focusing on the refugee crisis. This replaces education as the top issue from the 2013 poll - education came in third at 11 percent this year.

The University of Texas Professor Daron Shaw, PhD (Texas Lyceum Class of 2003) conducted the poll of 1,000 Texas adults which has a margin of error of + /- 3.1 percentage points. Dr. Shaw and Lyceum Research Director Joshua Blank, used the latest in polling techniques, contacting respondents both by landline as well as cell phones with the use of English and Spanish language instrumentation.
